4. First-Aid Measures

Description of first aid measures

General advice:

Hold eyes open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing.

If swallowed:

Never induce vomiting or give anything by mouth if the victim is unconscious or having convulsions. Do not induce vomiting. Have person sip a glass of water if able to swallow.

Most important symptoms and effects, both acute and delayed

Symptoms: No significant reaction of the human body to the product known. convulsions, CNS stimulation, tremors

Indication of any immediate medical attention and special treatment needed

Note to physician

Treatment:

Treat symptomatically. Anticonvulsant therapy as routinely administered to humans. Based on animal studies diazepam and phenobarbital prevented convulsions. Due to the slow elimination of the active compound and its metabolites, the treatment must be continued for several days, gradually decreasing the dose of anticonvulsant based on the clinical response.

5. Fire-Fighting Measures

Extinguishing media

Suitable extinguishing media: water spray, dry powder, foam, carbon dioxide

Special hazards arising from the substance or mixture

Hazards during fire-fighting: carbon monoxide, carbon dioxide, nitrogen oxides The substances/groups of substances mentioned can be released in case of fire. Aerosol container contains flammable gas under pressure.

Environmental precautions

Methods and material for containment and cleaning up

Dike spillage. Pick up with suitable absorbent material. Place into suitable containers for reuse or disposal in a licensed facility. If application of spilled substance/product is not possible, then spills should be contained, solidified, and placed in suitable containers for disposal.
